Executive Summary

At the time of writing of this fourth iteration, *Call Monitoring Report 4*, of the Reports on the StandICT.eu 2023 Open Calls, the project has now successfully launched a total seven Open Calls, of which the first six have led to the funding of 216 projects for a total of approximately 1.8 Million Euros of the 3 Million Euros earmarked for Financial Support to Third Parties. The 7th Open Call closed on the 06th of July 2022, with results to be finalised for mid-August and temporary outcomes dutifully showcased under section 2.8, and the 8th Open Call opening on the 6th of September 2022 following the leading theme *"Resilience and Green Transition"*.

The issue of this Report follows the Interim milestone of the Project, and therefore also provides an opportunity, with the project in full swing, to take stock of the consolidated Modus Operandi surrounding the StandlCT.eu 2023 Open Calls. Building on the successes underpinning the pre-cursor StandlCT.eu Project and further experience gained and improvements made over this first period of the project, the Consortium believes a virtuous, perpetuating cycle has been set in motion around the Open Calls. This runs from definition of the topics of the Open Calls, to their promotion through a widening outreach, to an improved evaluation process, and perhaps most significant of all, a timely, constant monitoring and tracking of the funded projects. At the same time, the continuous release of the Open calls has been adequately accompanied with the integration of new and relevant ICT domains to fully complement the demands from the European Commission to obtain inputs on fundamental (and arising) technologies in view of efficiently addressing gaps and challenges from a policy perspective (new domains are clearly outlined under Section 2).

This latter step ensures that the true potential of the outputs of the funded projects is harnessed, ensuring that they feed into the StandICT.eu European Observatory for ICT Standardisation – EUOS, that they are showcased in terms of impact created through the series of dedicated reports, Following the Fellows, being published for each Open Call in addition to the formal project deliverables, and are tracked both in terms of where each project fits into the technological or application domains of the Multi-Stakeholder Platform Rolling Plan for ICT Standardisation, in response to a recommendation made at the latest European Multi-Stakeholder Platform on ICT Standardisation meeting and further in terms of the creation or revision of new Standards, Working Groups, Technical Committees or Focus Groups.



1. Introduction

The first, second and third iterations of this deliverable, D3.1 'Call Monitoring Report - 1', D3.2 'Call Monitoring Report - 2' and D3.3 'Call Monitoring Report - 3' - were submitted in March 2021 (M7), October 2021 (M14), and February 2022 (M18) respectively.

For both the sake of coherence and ease of reference, the overall structure of these previous documents has been maintained. The deliverable therefore provides updated information on Open Call through Open Call #4 in terms of projects funded and closed, in Sections 2.1 through 2.4, and 4.1 through 4.4 respectively, while Sections 2.5 to 2.7 and 4.5 to 4.7 provide new information on the additional calls closed to Open Call 7. Section 5 provides information on the monitoring and impact of the funded fellows. This has also been updated with any minor changes to the reporting methodology in Sections 5.1 to 5.3, while 5.4 provides new and updated information with respect to the previous deliverable.

1.1 Scope and specific goals of the deliverable

The scope of the present document – which has public dissemination level – is to provide a detailed view of the outcome of the StandICT.eu Open Calls, in terms of received submissions, funded initiatives and the type of applicant, as well as other relevant information, such as outcomes of the calls in terms of the SDOs and standards dealt with by the funded proposals, and evidence of impact generated by projects closed under the first three Open Calls.

The main objectives of this deliverable are therefore:

- To provide information on the Open Calls released to date.
- To provide an overview on how the Open Calls were promoted (the overall promotional strategy is dealt with in greater detail in the dedicated deliverable D4.1 "Plan for the Communication & Stakeholder engagement strategy & Plan and promotion of the Open Call" (submitted in M3 – November 2020)
- To provide administrative information including the contractualisation of the applicants of the "Fellowship Programme" and the External Pool of Evaluators.
- To describe the online facility (Grants Platform), the overall infrastructure and the enhancements that have been carried out to date.

1.2 Structure of the document

The document is organised as follows:

- Section 2 provides a statistical overview of the applications received and funding granted through the 6 Open Calls closed and evaluated at the time of writing, as well as those on applications received in response to Open Call 7, currently under evaluation. An overview of the opening and closing dates of the calls with the relevant funding allocated and assigned to date is also provided.
- Section 3 provides a detailed, updated report on the composition and management of the External Pool of Evaluators (EPE) engaged under contract by StandICT.eu.
- Section 4 focuses on the applications received, providing details on the ranking and related applicants.
- Section 5 provides further information on the monitoring of the projects funded.
- Section 6 concludes the report, providing some lessons learned from the Open Calls.



1.3 Relationship to other deliverables and project outcomes

This deliverable updates the information provided in D3.1 'CALL MONITORING REPORT - 1' (M7) and D3.2 'CALL MONITORING REPORT - 2' (M13) and D3.3 'CALL MONITORING REPORT - 3' (M17). In addition, D4.1 "PLAN FOR THE COMMUNICATION & STAKEHOLDER ENGAGEMENT STRATEGY & PLAN AND PROMOTION OF THE OPEN CALL" (M3) and D4.2 "Interim report on COMMUNICATION & STAKEHOLDER'S ENGAGEMENT STRATEGY & PLAN AND PROMOTION OF THE OPEN CALL" (M18) set out in detail the actual methodology and set of actions carried out for the promotion of the Call(s).

Finally, in addition to the formal project Deliverables foreseen in the Grant Agreement and routine monitoring of the grantee reports, StandICT.eu 2023 also published the fourth of a series of Impact Reports foreseen to highlight the important achievements and evidence-based results obtained by the ICT Standards experts funded under the fourth Open Call, "Following the Fellows - Impact Report from funded applicants to 4th Open Call of StandICT.eu 2023 Fellowship Programme", released in June 2022.



2. Summary outcome of Open Calls completed to-date and plan for future Open Calls

2.1 Overview

StandICT.eu 2023 is pleased to report on the excellent level of response and the remarkably high quality of the proposals received during the 4 Open Calls closed and evaluated to date and the activities already concluded or underway under Open Calls #1, #2, #3, #4, #5, #6 and #7 which closed on the 06th of July 2022 and is currently under evaluation (results expected in the second week of August 2022).

The initial list of priority topics for the calls were taken from the Rolling Plan for ICT Standardisation. These were enriched over the course of the seven calls in domains such as *Edge Computing, Ontologies, Open Data Standards, Data Spaces, Cybersecurity Digital Services identified in the Act Digital Market Act, Digital Product Passport, Green Cloud Services, Metaverse, Microprocessor / Chips and in particular 'Trusted Secure Chips' Quantum Technologies, Robotics* coming from input from StandICT.eu 2023's partners, its External Advisory Group and members of the Technical Working Groups (TWG) in Blockchain, Cybersecurity, Artificial Intelligence, Big Data Spaces, Data Interoperability, Smart Cities and Trusted Information launched within the framework of its European Observatory – <u>EUOS</u>. 


Figure 1: Facts & Figures achievements over Open Call #1 - #6.

Figure 1 above provides an overview of the most relevant information on the 216 proposals funded under Open Calls #1- #6. This accounts for just over 1,858,341 euro in funding distributed directly to the ICT Standards experts and covering a broad range of key ICT technologies from the ICT Rolling Plan for Standardisation.

The wide spectrum of SDOs covered by the experts and the remarkable quality of the proposals which scored an average score of 8,54 (out of a maximum of 10) over Open Calls #1- #6 to meet the funding threshold.

The most popular topics remained stable with respect to the previous issue of this deliverable with Cybersecurity remaining at the top of the list of funded projects (37), closely followed by Artificial Intelligence (27), Blockchain and Distributed Ledger Technologies (24) and 5G (23). There was also continued traction in new technological areas such as Quantum Technology, which reached 12 funded projects with OC #6, and Semantic Interoperability which reached 9, while other topics remained stable such as Smart Cities (8), Fintech and Regtech (7), Electronic Identification and Trust Services, Intelligent Transport Systems (4), Internet of Things (4), Ontologies (4).

The following provides a summary of the outcome of each Open Call, as well as some statistics on the typology of the applications and the successful applicants, with a clear breakdown of each area of interest. The statistics on Open Call #7 pertain exclusively to the received and eligible applications.



As explained previously, the summary information provided for Open Calls #1-#4 in this section of the deliverable is static, as this refers to the Open Calls already closed at the time of writing the previous iteration D.3.3 and provided once more for ease of reference.



2.2 Summary outcome of the 1st Open Call

Open Call #1 opened on 02/11/2020 and closed on 04/01/2021. Figure 3 below provides some of the main statistics of the Open Call #1, including a breakdown of the winning proposals by the most popular topics and SDOs represented, as well as the type of organisation of provenance of the applicants. Open Call #1 also marked the highest number of received applications so far (96 eligible proposals submitted).




Figure 5: StandICT.eu 2023 OC #2 statistical overview funded fellows

Open Call #2 opened on 11/01/2021 and closed on 11/03/2021. Once more, Figure 5 below provides some of the main statistics of the call, such as the breakdown of the winning proposals by topic covered and reference SDO and the type of organisation of provenance of the applicants. With respect to the 37 applicants selected for funding, three applicants withdrew their application just after contract signature (one of whom to successfully re-apply to the third Open Call) taking the final number of funded fellows to 34.

2.4 Summary outcome of the 3rd Open Call




Figure 6: StandICT.eu 2023 Open Call #3 Promotional Banner




Figure 7: StandICT.eu 2023 OC #3 statistical overview funded fellows

Open Call #3 opened on 18/03/2021 and closed 18/05/2021. Figure 7 below again provides some of the main statistics of the call, such as the breakdown of the winning proposals by topic covered and reference SDO and the type of organisation of provenance of the applicants. With respect to the 35 applicants selected for funding, one applicant withdrew their application just after contract signature taking the final number of funded fellows to 34. Open Call #3 saw the funding of new topics such as Identity Management, Emergency Communications, Semantic Interoperability and Electronic Identification.




Figure 9: StandICT.eu 2023 OC #4 statistical overview funded fellows

Open Call #4 opened on 15/07/2021 and closed 06/09/2021. Figure 9 below again provides the breakdown of the winning proposals by topic covered and reference SDO and the type of organisation of provenance of the applicants. A slightly higher number of applicants, 38 fellows for a total amount of 322 KEURO were funded to compensate for the withdrawals under OC# and OC#3Open Call #4 welcomed funding such Fintech and Regtech and Intelligent Transport Systems.




Figure 11: StandICT.eu 2023 OC #5 statistical overview funded fellows




Figure 13: StandICT.eu 2023 OC #6 statistical overview funded fellows




Figure 15: StandICT.eu 2023 OC #7 overview applications received

2.9 Allocated Budget, Proposals Funded and Call timings

Table 1 below presents the financial status in terms of allocated budget from Open Calls #1 to #6, the proposals retained for funding, and those actually funded, i.e. net of funds in those cases where fellows withdrew a winning proposal or failed to proceed to contract, which explains the slight differences between [A] and [B]. This will be closely monitored over the course of the coming calls so that any



funding remaining with respect to the amount earmarked for each call is re-allocated under the subsequent calls to ensure that all of the funding available for the experts is utilised without compromising the very high quality of the proposals selected.

The table is made on the assumption that StandICT.eu 2023 reduces the overall number of the open calls to compensate for the additional costs incurred for the newly improved evaluation process introduced from OC#2, fully described in Section 3.2, with more detailed information on the provisions and contingencies to manage this provided in Section 3.4.

3. External Pool of Evaluators (EPE)

As reported in D3.1, D3.2, D3.3. and in accordance with the Grant Agreement, the evaluation of the applications received in response to the Open Calls is outsourced to a mix of ICT experts from each of the priority domains and vertical sectors, which come together in the StandICT.eu External Panel of Evaluators (EPE).

The EPE were also selected through an Open Call process via the Grants Management Platform. This call was launched on the 1st October 2020 and closed on the 30th November 2020.

3.1 Composition of the EPE

One hundred and twenty-four applications were received in response to the Open Call. Encouragingly, a number applicants had already been engaged as evaluators for the pre-cursor StandICT.eu project. The applications were evaluated and pre-selected by one senior member per Consortium Partner on a unanimous basis. This list was subsequently ratified by the Project Management Board (PMB).

As a result, 73 applicants were accepted and 9 placed on a reserve list, overachieving the KPI of 50+ and providing good domain-topic and geographical coverage, as well as gender balance (based on the number of applications received). Sixty-three applicants were placed under contract with due provision for Conflict of Interest and Confidentiality ready for the evaluation of the Open Calls.

At the time of writing, the pool is formed of 51 members, following withdrawals, in almost all cases to apply to the Open Calls for funding.

A list of the current EPE is shown in Table 2 below. Given the public dissemination level of this deliverable, this is limited to name, surname, organisation type, country, proposal ID, and contract no.



Finally, pursuant to art. 204 of the EC financial regulations (Title VII, "Experts") and Art. 287 of the Rules of Application, paragraph 5, the list of the EPE members under contract with StandICT.eu that received compensations in 2021 is provided in table 3 and published on the StandICT.eu website (here https://www.standict.eu/call-evaluators-closed).

Of note is also the good mix of specialists from different organisation types such as SMEs, Research and Academia, IT Consultancy development and Government/Public Service. A number also have a dual role, as engaged experts, of SDOs and National Standards Bodies.

3.2 EPE Assignment and Assessment of the work carried out

Prior to assigning the EPE to the proposals received, the EPE were mapped in terms of their areas of competency to match them to the applications received in response to the open calls and maintain a good geographical and gender balance among the three EPE members allocated to each proposal.

To avoid situations where a skewed score given by one of the three evaluators assigned had a negative impact on the evaluation, or led to discordant comments which would then be shared as feedback to the applicants, from Open Call #2, one of the evaluators allocated to each application was also assigned the role of Rapporteur. This evaluator was tasked with editing and summarising the individual comments from each evaluator into one succinct piece of text to be provided in the comments box for the score given to each criterion and to propose a new score, where appropriate, via a dedicated discussion panel implemented for each application.

This became the basis for the Consensus Report (CR), to be shared as feedback to the applicants, as opposed to simply averaging the score and making the three separate sets of comments visible to the applicant via the platform, as originally foreseen under the Grant Agreement. Further, a step of Quality Assurance was also introduced and performed by a fourth member of the pool. The Quality Controller was tasked with checking the text and coherence of the Consensus Report, reworking the wording if



necessary and to raise any evident inconsistencies still existing after Consensus and raise this with the Call Team.




Figure 17: The Evaluation Workflow

An overview of the overall process is shown in the Fig. 17 below, while an exhaustive explanation of each step is provided to the evaluators via the Briefing Pack, annexed to D3.1.

The EPE were also trained on the process via a dedicated online webinar and a special reserved area was set up for the EPE on the StandICT.eu website, where they could access the training documentation (updated where necessary from call to call), a recording of the webinar and a demo of the online processes.

On the basis of experience gathered when this was rolled out during OC 1 and OC 2, and valuable input provided by the EPE, during OC 3 a further step was introduced whereby the QC was given the rights to refuse the CR in the system in the event of inconsistencies in comments and/or scores and return this to the Rapporteur for further re-editing/re-scoring. As part of this process, the Quality Controller also has visibility via their dashboard of the comments made in the discussion panel by the individual evaluators during consensus.

It is believed that this is a greatly improved process, which not only results in a more transparent and fair scoring system, but also serves to provide useful feedback to the unsuccessful applicants for resubmission of the proposals to subsequent calls.

3.3 **EPE Payments**

The EPE were paid on the basis of 400 Euro per day, or 50 Euro per hour. An initial, once-off payment of 4 hours for set-up on the system, reading and assimilation of the briefing documents and participation in the training session was made upon the assignment of the first proposal, after which the EPE were paid 40 mins for each proposal evaluated, including interaction with the other evaluators during



consensus, 60 mins for each Rapporteur role and 40 mins for Quality Control. The latter equated to a cost of 183,33 per evaluation as shown in Table 3.

3.4 Budget Contingency to cover improved evaluation process

Roll out of the new, improved evaluation procedure with the introduction, of the Rapporteur and Quality Controller role greatly improving the overall fairness of the evaluation process, and ensured consensus between the evaluators assigned to the proposals before ranking or feedback to the applicant, reducing also the risk of redress on behalf of the applicants. This did imply higher costs than those initially foreseen to cover the extra effort of the EPE.

To address this, the Project Management Board discussed and agreed upon a contingency to contain these costs by i) reducing the overall number of open calls from ten to nine and ii) capping the applications to be evaluated of the first seventy, as well as devolving savings made in budget from travel and other direct costs due to covid to offset the remaining amount-

Table 5 and Table 6 respectively show the estimate to completion using the measures described above to manage the nine calls and the remaining unspent budget to be devolved to cover this.

4. Applications received and funded

An overall total of 416 eligible applications were submitted for funding from Open Call #1 – Open Call #7. Overall, the standard of the proposals was extremely good resulting in a total of 216 proposals funded under Open Call #1 – Open Call #6 for a total of 1,858,342 Euro with an overall average score for funding under the 6 Open Calls of 8,5 to the budget depletion level of approximately 300,000 Euro per Open Call.

The contractual process with the grantees took approximately two-three weeks, depending on how quickly they reacted in verifying their personal information and returning the duly executed documentation to start activities. This set in motion the process to align the start and end dates for their work, where necessary, and kick off reporting and monitoring via their dashboard, as fully described in Section 5.

The contract in itself was straightforward and concise and with due attention to EU provisions such as Article 35 (conflict of interest), Article 36 (confidentiality), 38 (communication obligations) and right to audit. This also **included provision for entry into force upon signature with retroactive effect to the start date indicated for the activity at proposal submission** (implemented on the portal for submissions made from OC 3). This improved the turnaround time to gather the first results and impact of the open calls considerably and enabled the majority of the fellows to start their activities upon notification of funding.

Of note, a slightly modified construct of the contract following that of the above was implemented for those cases whereby a specialist was not able, for employment or other reasons, to receive the fellowship directly. This followed the same structure as that mentioned above, with a clear undertaking from the university or organisation to devolve the fellowship in its entirety to the individual without any overheads or administrative charges.

A full list of the applications received in response to OC #1 to OC #6, with proposal ID, Score, Funding allocated and Contract No. is provided in 4.1-4.6 below with details of the 71 eligible applications received in response to Open Call #7, yet to complete the evaluation and assignment process in 4.7.

As mentioned above, details on the monitoring of each contracted fellow, the status of the projects and impact generated is covered in Section 5.

4.1 Applications submitted and funded under Open Call #1

A full list of the eligible applications received to Open Call #1, including those not retained for funding, is provided in Table 7 below, in order of ranking with the proposal ID and the contract number, the funding granted [B] against requested [A] and the amount paid at the date of writing [C]. The grey-shaded applications are those that were withdrawn, or for which the contract was cancelled subsequent to issue.

5. Monitoring of the Funded Fellows and Impact

5.1 Monitoring Methodology

The StandICT.eu 2023 Fellowship Programme monitoring is supported by the Logical Framework Approach (LFA) allowing to analyse and organize the gathered monitoring information in a structured way. Within this framework, the following project aspects are controlled:

- Identification of successes and problems during the fellowship implementation.
- Informed and timely decision making by project manager to support the implementation.
- Accountability for the activity and results achieved.
- Fellows' contribution to the dissemination of the results and participation in the StandICT.eu 2023 Programme.
- Assessment and validation of the fellowship's achievements and activities.


The TRUST-GRANTS™ platform enables to implement the LFA in practice and to track down all the required fellowship data. Moreover, to gather the fellowship performance data, the funded fellows are requested to provide a set of monitoring elements:

For the One-Shot and Short-term fellowships (up to 3 months) three monitoring elements are requested: the fellowship work plan (defined in the application), the project summary (provided during the contracting phase) and the final report (submitted for the project end date).

For the Long-Term fellowships (up to 6 months) four monitoring elements are requested: the fellowship work plan (defined in the application), the project summary (provided during the contracting phase), the interim report (submitted in the mid-term of the project) and the final report (submitted for the project end date).

5.2 **Monitoring Tools**

The TRUST-GRANTS™ platform enables monitoring of the fellowships progress in real time based on the start and end dates of each individual funded fellowship, as well as on the work plan provided as a part of the fellowship application. The project team consults the platform daily to identify new achieved fellowship milestones (namely, interim, and final report submissions) and possible deviations. Only the designated StandICT.eu team members are granted rights to access the project monitoring tool on the platform.



The fellows perform their reporting via Trust-Grants respecting the set deadlines (at the mid-term and/or at the end of their fellowship).

The Interim report, that LT fellows submit at their project M3, enable to follow the mid-term progress of the fellowships monitoring namely: the concerned standardisation challenges and gaps, the addressed SDOs, WGs and TCs, the number of participated meetings, webinars, workshops as well as the overall progress compared to the initial work plan.

The Final report, submitted at the end of the fellowships (at M3 or M6 based on the fellowship type), contain questions regarding the achieved standardisation activities but also on the project's impact on SMEs, on the society as well as the possible contributions to the EUOS Work Groups.

The StandICT.eu 2023 project managers review the content and the quality of all submitted reports, and if the set quality criteria are met, the reports are validated enabling the project to move towards the next milestone. These criteria concern to assess the consistency of responses in the open question, if all questions are addressed, and if the data provided enables to understand the main achievements and to draft the performance story.

Upon the validation of the submitted final report, Trust-IT administrative team is notified, and they launch the grant payment process. In case that the submitted reports do not meet the set quality criteria, the re-submission of the report is requested with information on the improvements to be done for the validation of the fellowship.

5.3 **Impact Assessment**

To raise awareness about the monitoring process and the impact assessment, StandICT.eu 2023 team run a twofold communication process, *internal and external*.

To keep the monitoring process running smoothly, AUS is in daily contact via emails with the funded fellows making sure that the fellows are aware of the available reporting tools and the set deadlines. In case of delays or other foreseen complications during the fellowship, AUS connects the fellow with TRUST-IT team to mitigate all risks impacting the project as quickly as possible.

The external communication related to the monitoring focuses on the impact assessment and dissemination towards the StandICT.eu 2023 community. It includes a series of fellowship impact reports as well as regular communication on StandICT.eu social media channels, in Twitter¹ and in LinkedIn², as well as Impact success stories. More information is available in *D3.4 Interim impact report*.

Moreover, a series of dedicated impact reports, in addition to the formal deliverables of the project are being published, each showcasing the activities, impact and results deriving from the funding provided under each open call. The aim of these impact reports is to share insights from the key standardisation activities performed, as well as giving visibility of the results and the StandICT.eu 2023 community within the ICT standardisation community. The First Impact Report covering OC1 was published in August 2021³, the second, covering OC2, was published on December 2021⁴, the third, covering OC3, was published on March 2022⁵ and the fourth, covering OC4, was released in June 2022.⁶

5.4 Current Monitoring Status of the Fellowship Programme

From the beginning of March 2021 (M7) onward, 416 funded fellowships are currently monitored. AUS monitors the overall status and progress of the fellowship programme under the different fellowship batches:

Batch 1 (funded under OC#1) covered 35 fellowships; the monitoring started in March 2021. This batch, comprising 2 Short-term (ST) fellowships and 33 long-term (LT) fellowships, is now closed, with all final reports submitted.

Batch 2 (funded under OC#2) funds and follows 36 fellowships, the monitoring started in July 2021. This batch includes 6 ST fellowships and 30 LT fellowships, and the monitoring progress is closed.

Batch 3 (funded under OC#3) comprises 35 fellowships including 1 ST fellowships and 34 LT fellowships. This monitoring started in September 2021. This batch is almost closed, with just 1 final report to be submitted (deadline 1st of August 2022)




Figure 20 Batch 4 – OC#4 Fellowship Monitoring Status

Batch 4 (funded under OC#4) comprises 38 fellowships including 4 ST fellowships and 34 LT fellowships. The monitoring of these fellowships kicked off in December 2021. The monitoring of this batch is almost closed, with just 3 final reports to be submitted, as shown in Figure 20.




Figure 21 Batch 5 – OC#5 Fellowship Monitoring Status

Batch 5 (funded under OC#5) comprises 38 fellowships including 4 ST fellowships and 34 LT fellowships. The monitoring of these fellowships kicked off in December 2021, therefore, given that was just one month from submission of this deliverable, the reporting is mostly interim (12 reports) with 2 final reports submitted at the time of writing, as shown in Figure 21.

Batch 6 (funded under OC#6) comprises 38 fellowships including 3 ST fellowships, 3 OS fellowships and 31 LT fellowships. At the time of writing this deliverable, one fellow still needs to finalise the contract with us. Therefore, in Figure 21 below, we took into consideration a total of 37 fellowships (of which 31 are LT and the rest divided between ST and OS fellowships). The monitoring of these fellowships kicked off the first of June 2022; for this reason, the number of reports submitted is still low.




Figure 22 Batch 5 – OC#5 Fellowship Monitoring Status

To monitor the impact achieved by the fellowship programme, the new/revised standards new Working groups or Technical Committees created during the fellowships were also tracked.

At the time of writing, some 141 fellowships (from OC#1 to OC#4) have been analysed, and the following has been observed

Fellows Contributing to New/revised standards

OC#1: 26/35

OC#2: 19/34

OC#3: 27/34

OC#4: 32/38

meaning 74% of funded fellows contribute to new/revised standards.

Fellows Contributing to new WGs/TCs

OC#1: 28/35

OC#2: 10/34

• OC#3: 13/34

OC#4: 14/38

meaning that 46% of funded fellows contribute to new WGs/TCs.

The impact of each open call will continue to be gauged as part of the monitoring activities and the results provided in the forthcoming deliverables.

6. Lessons learned and next steps

Once finished the key-priorities of the "Strategic Plan for Horizon Europe" and the correlated global challenges for European competitiveness that represented the leading themes of the first six Open Calls of the project, the Consortium decided to focus the last 3 Open Calls on more specific technological trends to emphasize their relevance within the new EU Strategy on Standardisation, more precisely:

- Artificial Intelligence, Data and Robotics (07th Open Call)
- Resilience and Green Transition (08th Open Call to be launched in September 2022)
- IoT, Clou and Edge (2023)

Some new trends, communications action points and takeaways that emerged in the course of the latest Open Calls are listed below:

- As part of the Impact-tracking task, each funded fellow has been individually contacted and
 asked to contribute to provide tailored insights in the EUOS Open Discussion Forum with a
 view to turn the platform in a more updated source of information and meaningful debate
 tackling the various ICT domains. This resulted in a significant increase of discussion's threads
 and comments in M22 and M23, on top of the periodic roll-out of the "Following the Fellows –
 Impact Report" (now at the 04th release).
- Following the inputs coming from the EAG Board and the European Commission (upon the
 release of dedicated plans such the "Circular Economy Action Plan" or the proposal for a
 "Regulation on Ecodesign for sustainable products"), new ICT domains have been
 permanently included in the Open Call's priority list, namely Digital Product Passport, Edge
 Computing, 6G and Trusted Secure Chips.
- The critical role of the Fellows has been also leveraged to provide an important contribution to the definition of European policy in different areas of ICT Standardisation. In this regard, some fellows have been encouraged and invited to join strategic EUOS Technical Working Groups to bring different perspectives and tackle the policy aspects in different ICT domains.
- The dissemination of the Open Call's data and statistics has been improved by releasing a dedicated infographic that showcases a thorough breakdown of the funded proposals according the rationale of the Rolling Plan for ICT Standardisation and splitting the areas in the four plan's thematic areas in pursuit of a more detailed understanding of the results (*Key enablers and security, Societal challenges, Innovation for the Digital Single Market, Sustainable growth*).
- At the moment of writing, 22 European and International SDOs could benefit of the supportive
 activity of at least a funded applicant while 8 had benefitted of more than 10 individuals. The
 SMEs component is still the most represented with 44% of the funded fellows coming from
 small or medium companies.
